

**HEREFORDSHIRE COUNCIL**  
**(VARIOUS TRAFFIC MOVEMENTS) (CONSOLIDATION) ORDER 2022**  
**(VARIATION) ORDER No.2 2026**  
**(VARIOUS ROADS, HEREFORDSHIRE)**  
**(PROHIBITION OF DRIVING, PROHIBITION OF MOTOR VEHICLES AND PROHIBITION**  
**OF MOTOR VEHICLES (EXCEPT FOR ACCESS))**

The County of Herefordshire District Council, known as Herefordshire Council in exercise of its powers under Sections 1, 2 and 4 of Part I and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the 1984 Act) and the Traffic Management Act 2004 (the 2004 Act) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, proposes to make the above-named Order. The effect of this Order is to introduce the restrictions set out in the Schedule below.

Restrictions to be introduced

**Prohibition of Driving**

<b>Road Name &amp; Number</b>	<b>Extent</b>
Sellack Restricted Byway 14 (SK14), Peterstow	For its entire length.

**Prohibition of Motor Vehicles**

<b>Road Name &amp; Number</b>	<b>Extent</b>
Quebb Road (U90617), Eardisley	From its junction with Upper Welson Road (U90616) to a point approximately 670 metres south-west of its junction with A4111. A distance of approximately 840 metres.
Brockhampton Byway 14 (BKR14), Fownhope	From a point 285 metres south-west of its junction with B4224 to a point approximately 402 metres north of its junction with the C1272. A distance of approximately 206 metres.
Hope Mansell Byway 14 (HM14), Hope Mansell	From its junction with High Church Road (U70200) for a distance of approximately 951 metres in an easterly direction.
Macadams Lane (U71229), Llangaron/Ganarew	From its junction with Trewarne Lane (U71227) to a point approximately 455 metres north of its junction with Greenway Lane/Sellarsbrook (U71230). A distance of approximately 1,064 metres.

**Prohibition of Motor Vehicles (Except for Access)**

<b>Road Name &amp; Number</b>	<b>Extent</b>
Spoon Lane (U75218), Dorstone	From its junction with The Scar (U75219) to a point approximately 213 metres north-west of its junction with B4348. A distance of approximately 1,610 metres.
Canon Pyon Byway 32 (CP32), Westhope	From its junction with Westhope Hill (U93402) to a point approximately 355 metres south-east of its junction with Chapel Lane (U93403). A distance of approximately 929 metres.

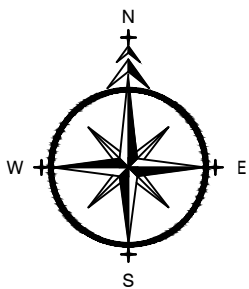
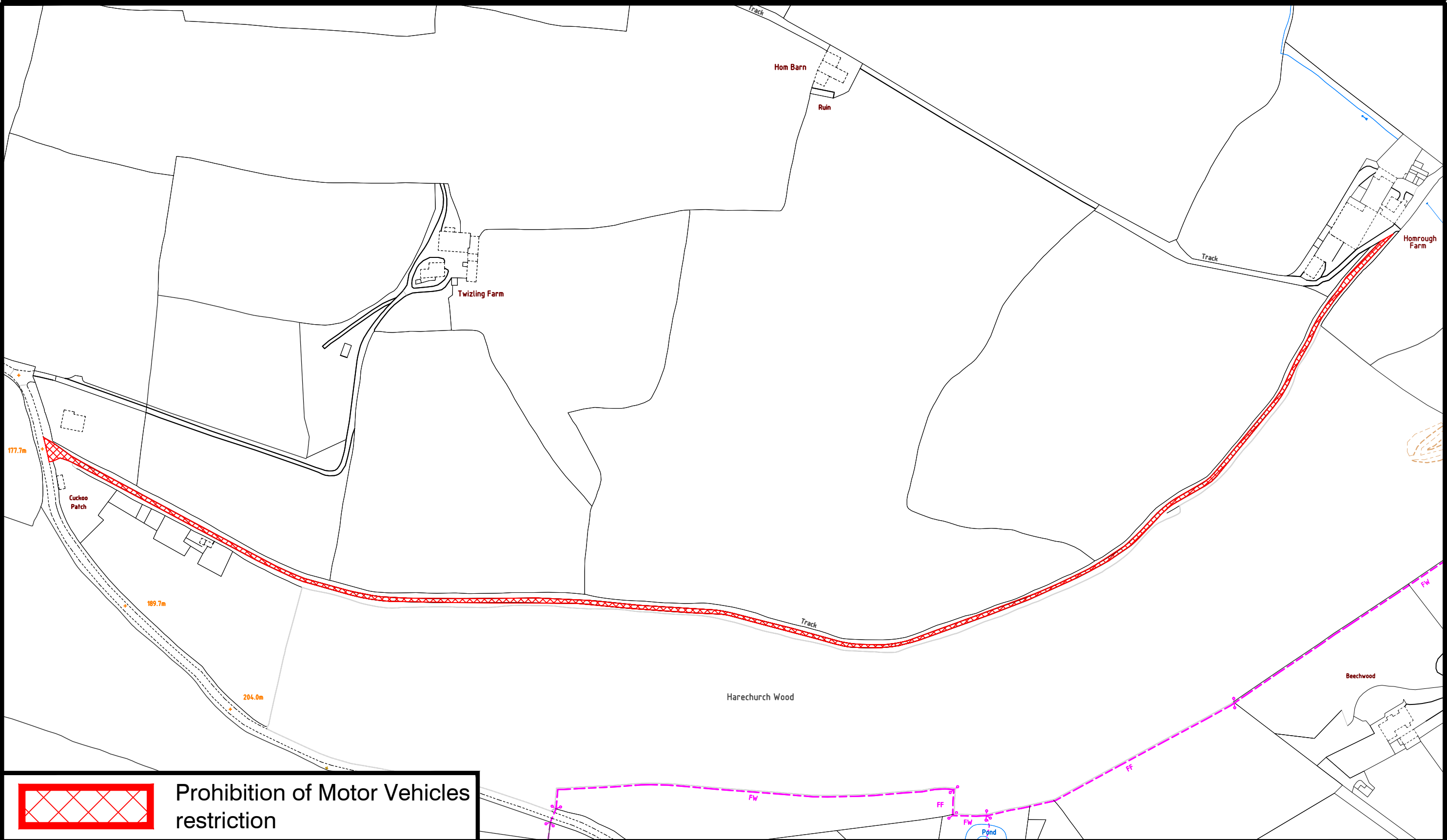
